Determination of Advances made under sub-section 164-10 of the Higher Education Support Act 2003 (the "Act") on account of amounts expected to become payable under section 128-1 of the Act (SA-HELP Advances-2017)

I, KATERINA LAWLER, delegate of the Secretary for Education for the purposes of sub-section 164-10(1) of the Act:

## **DETERMINE:**
