Determination of Advances made under sub-section 164-10 of the Higher Education Support Act 2003 (the "Act") on account of amounts expected to become payable under section 128-1 of the Act (SA-HELP Advances-2022)

I, DAMIAN COBURN, delegate of the Secretary for Education for the purposes of sub-section 164-10(1) of the Act:

DETERMINE:

(a) that an advance is to be made to each Higher Education Provider ("HEP") listed in Column 1 of the table, below, (the "Table") on account of a total amount that is expected to become payable to the HEP under section 110-1 of the Act in respect of the year 2022 ("**Advance**"); and
