Determination of Advances made under sub-section 164-10(1) of the Higher Education Support Act 2003 (the "Act") on account of amounts expected to become payable under section 124-1 of the Act(OS-HELP Advances-2024)

I, ANNETTE CANNELL, delegate of the Secretary for Education for the purposes of sub-section 164-10(1) of the Act:

DETERMINE:
